Professional Fitting and Dispensing Services

The See Clearly Work Safely prescription safety eyewear program includes complete dispensing services provided by a SafeVision partner Eye Care Provider.

Off-site dispensing services are available through our vast network of more than 3,500 Providers.

On-site dispensing services, administered by SafeVision contracted opticians, may also be available for qualifying accounts.

The Eye Care Provider will assist employees with proper frame and lens selection, take the necessary optical measurements, place the order with the HOYA lab to be completed and shipped to their location in approximately 10-14 business days.

Additionally, our Eye Care Providers offer routine adjustments or maintenance and will also handle any warranty needs.

A physical copy of the employee's current prescription (no older than two years) is required. Eye exams are not part of the program.



All Programs Include:



- ✓ All lens styles including No-Line Progressives
- ✓ Phoenix or Polycarbonate lens material with choice of clear or tint (Both materials are high impact rated per the ANSI Z87.1 standard)
- ✓ Pentax safety frames with permanent or detachable sideshields and carrying case
- ✓ Shipping
- ✓ Professional dispensing services via an Eye Care Provider or on-site optician if applicable
- ✓ Comprehensive warranty and remake policy
- ✓ Package 2 & 3 include choice of a warrantied scratch, anti-fog, or anti-reflective treatment

How the Program works:



1. Select one of the 3 Programs.
2. Schedule a discussion with a SafeVision Representative to establish the guidelines of the program such as permanent or detachable side shields, frame assortment and any employer paid add-on options.
3. A customized order form and unique web link are created with the option for either employees or supervisors only to download the form.
4. Employee selects a local eye care provider through the online SafeVision network search tool.
5. Upon visiting the chosen provider, employees can select their safety eyewear, get fitted and return once the order is completed for final adjustments.
